## What's new in Horizon 2020?



- A single programme bringing together three separate programmes/initiatives\*
- Coupling research to innovation from research to retail, all forms of innovation
- Focus on societal challenges facing EU society, e.g. health, clean energy and transport
- Simplified access, for all companies, universities, institutes in all EU countries and beyond





## **Challenge 6 – Sample Call Details**



#### EURO-1-2014: Resilient & sustainable economic and monetary union in Europe

#### Scope:

- 1. Effective mechanisms of fiscal policy coordination in the EU  $\rightarrow$  should explore the problem of fiscal sustainability in the EU & potential models of fiscal union
- 2. Fair and sustainable taxation  $\rightarrow$  a comparative study of European and non-European taxation systems & potential of further European tax harmonization
- 3. The impact of macroeconomic and social imbalances on economic stability  $\rightarrow$  analyse the main features of macroeconomic, social and financial imbalances within and between the EU MS
- The global impacts of the crisis in Europe and the international monetary relations  $\rightarrow$  review the 4. evolution of the global monetary system in the last decades & explore the impacts of the crisis on global power shifts

#### **Expected Result:**

- advance theoretical and practical debates on a more resilient and sustainable economic and ٠ monetary union in Europe
- develop a comprehensive and coherent vision on how to ensure the long-term sustainability and • resilience of the European economic system.
- New concepts, methodologies and tools developed by research will support European decision • makers and practitioners in the setting-up and implementation of a reinforced governance architecture in the EU 33

## Sample social sciences project in FP7



# ACCEPT PLURALISM: Tolerance, Pluralism and Social Cohesion. Duration: 3 years, 2010-2013 Budget: 2,6 million Euro , 19 partners (İstanbul Bilgi University from Turkey)

- an in-depth study of tolerance to and acceptance of native minority groups and migrants - concentrated on education and politics in 15 European countries
- developed a <u>theoretical framework</u> for researchers
- the framework was applied to 8 case studies: 4 in <u>School Life</u>; 4 in <u>Politics</u>
- the findings of case studies presented in the project's <u>European Policy Briefs</u>
- published a <u>Handbook on Tolerance and Cultural Diversity in Europe</u>, as a training tool for teachers
- formulated a set of <u>Tolerance Indicators</u> in school life and in politics that can be used for self-monitoring or assessment of the overall "tolerance index" in different countries
- published A Pilot Study using the indicators to showcase how different countries do better or worse along different issues and with regard to different minority groups.

- Developing scientific citizenship by promoting innovative pedagogies in science education, attracting more young people towards science, with a special emphasis on girls, and addressing the challenges faced by young people, in pursuing careers in science, technology, engineering and innovation;
- Developing Responsible Research and Innovation in Higher Education Curricula;
- Easing the access to scientific careers by increasing the service level of the EURAXESS Services Network.

- Fostering the dissemination of information and good practices through a Knowledge Sharing Platform (KSP), including networking, monitoring and assessing relevant initiatives;
- Supporting structural change in the research organisation and higher education institutions to promote Responsible Research and Innovation.

## SwafS – Sample Call Details



#### **GERI-2-2014** – Impact of Gender Diversity on Research and Innovation

- **Challenge:** Some studies have explored the impact of gender diversity on innovation in terms of productivity, performance and relevance to society (e.g. number of publications and of patents, market shares).
- However gender diversity in teams and organisations has not yet been systematically analysed.
- **Scope:** develop concepts and methodologies for the evaluation of the impacts of gender diversity in research teams and organisations on research quality and productivity
- & apply the concepts and methodologies developed to a selected range of sectors using a comparative approach across countries.
- **Expected result:** The research will provide a better understanding of the relationship between gender diversity and Research and Innovation performance.
- In the medium term, it shall help develop appropriate conditions for to contribute to research intensity and productivity. 45



HULDA, the European Arts and Sciences Sailing Festival Duration: 2,5 years, 2008-2010 Budget: 800.000 Euro, 14 partners (Turkish Coordinator + 3 partners from Turkey)

- created an innovative strategy to raise the interest of youth and civil society by bridging art, science and daily life
- conducted engaging workshops for young students in 10 cities and communicated interesting science themes in ingenious ways
- created alternative perspectives to awaken public interest in science, exploiting art as a tool to communicate science in novel ways
- has also established a pan-European network of stakeholders and project beneficiaries linked with schools and other institutions so as to reach students
- provided children and youth with the chance to work with their peers on creative scientific experiments
