Students whose thesis proposal is accepted must log in Thesis Automation System ([/giris.jsphttps://tez.yok.gov.tr/UlusalTezMerkezi](https://tez.yok.gov.tr/UlusalTezMerkezi)) in order to fill out "Thesis Data Entrance Form" and submit it to their advisor. The Thesis Data Entrance Form approved by the advisors must be sent to the e-mail address (fbe@atilim.edu.tr) of the Graduate School.

• The student who passes doctorate qualifying exam successfully defends his/her thesis proposal covering the purpose, method and study plan of the research before the thesis monitoring committee within maximum six months. The student delivers to members of the committee minimum fifteen days before verbal defense the written report about the thesis proposal.

*For the student whose thesis proposal is accepted, the thesis tracking committee convenes twice a year, between January and June and July and December. The student submits his/her written report to the committee members at least one month prior to meeting date. The report gives summary of the studies conducted up to that date and the plan of study to be conducted in the one year thereafter.

**Justified report must be presented. The student is given one month for revision. After the end of that period, the student defends the proposal again. The decision taken with absolute majority after defense is submitted to the department with a defense report.

***Justified report must be presented. The student whose thesis proposal is refused is entitled to select a new advisor and/or thesis subject. In such case, a new thesis monitoring committee may be appointed. The student wishing to continue the program with the same supervisor makes his thesis proposal defense within three months while the student changing his supervisor and/or thesis topic makes thesis proposal defense within six months. The student whose thesis proposal is rejected in this defense session again is dismissed from the University.

**** Justified report must be presented for opposite vote.
